FY 2024 and 2025 HUD CoC Notice of Funding Opportunity and FY 2024 Local Project Application Competition Timeline

The U.S. Department of Housing and Urban Development (HUD) released the Notice of Funding Opportunity (NOFO) for Fiscal Year 2024 and 2025 Continuum of Care (CoC) Competition on July 31, 2024. The Continuum of Care (CoC) Program is designed to promote a community-wide commitment to the goal of ending homelessness; to provide funding efforts for efforts by eligible non-profit providers, local governments, and States to quickly rehouse homeless individuals, families, youth, and persons fleeing domestic violence, dating violence, sexual assault, and stalking while minimizing trauma and dislocation caused by homelessness; to promote access to and effective utilization of mainstream programs by homeless individuals and families, and to optimize self-sufficiency among those experiencing homelessness.
