ELECTIONS DIVISION

During the month of February, the focus of the Election Division activities were on the following tasks:

House District 45 Election:

Staff is preparing for the April 5th Special Election. An emergency move of precinct SS19A was rendered by the superintendent, due to the unavailability of the hosting facility. The relocation was advertised in the legal organ and the Registration Division has mailed notice to all affected voters.

Supplies & Logistics - Polling Locations:

Staff is currently conducting inventory and preparing for full usage of the WDS inventory system.

Relocation signs have been redesigned and ordered for the thirteen May 24th polling place change proposals. Please see attached revised BOC map for review. Additional proposals and maps of redistricting changes will be provided, for information purposes, once completed.

Absentee Ballot Drop Boxes:

One absentee drop box will be placed at the Advance Voting location for the April 5th Election. Approved Absentee Ballot Drop Box locations have been posted on the Fulton County Website for the April 5th and May 24th elections. Signage to provide clear guidelines regarding drop box usage are being created as an Advance Voting supply item.

Poll Worker Recruitment & Training:

All training documents are being reviewed for any necessary edits and/or updates, poll working training will begin on March 7th. Recruitment for Election Day workers has commenced. The Voter Education Team will be coordinating recruitment fairs with municipalities that have expressed interest. To date the following municipalities are coordinating recruitment fairs:

REGISTRATION DIVISION

This Monthly Report provides a summary of the critical registration activities, workload levels, and voter registration statistics for the Registration Division of the Fulton County Registration & Elections Department for February 2022. The primary activities the VR staff worked on in February were processing voter registration applications, Redistricting, confirmation notices, researching street issues, municipal street audits, processing registration issues, preparing notices to voter registration applicants, scanning, indexing registration cards, and training.

VOTER REGISTRATION

The total number of voter registration applications we received in 2022 is **19,015**. This number includes voter registration applications received via the Department of Driver Services, the Online Voter Registration portal with the Secretary of State's Office, applications from 3rd party vendors, and applications mailed or dropped off at our office.

As of February 28, 2022, there are 841,926 (736,896 active and 105,030 inactive) registered voters residing in Fulton County.

Preparation of 2022 Elections

2022 Qualification of Candidates

The qualification period is scheduled for 9:00 AM, March 7 – Noon, March 11, 2022. The nonpartisan offices of State Court Judge, Magistrate Judge and Board of Education Members will qualify in our office. The partisan offices of Board of Commissioners will qualify at their party's executive committee office.

VOTER EDUCATION AND OUTREACH

This report provides specific summary information regarding VEO tasks performed during February 2022. Standard Voter Education and Outreach operations include:

- Educational seminars and lectures.
- Comprehensive demos and training.
- Voter registration activities.
- Assisting in Poll Worker Recruitment
- Deputy Registrar Training

In February, the VEO team was able to do the following:

- Train 65 new Deputy Registrars for a total of 130 for the year
- Register 36 citizens to vote
- Host 15 events
- Recruit 20 poll workers
- Make connections with 125 organizations, companies, municipalities, and elected officials to plan for Voter Education events
- Received one media inquiry on Voter Education and Outreach events with the Mobile Bus Unit

The VEO Team continues to implement the 2022 Voter Education and Outreach Plan. In February, the VEO Manager has reached out to municipalities within Fulton County to host poll worker Recruitment fairs/voter outreach events. To date, Chattahoochee Hills, Milton, Alpharetta, Sandy Springs, Fairburn, South Fulton, East Point, Hapeville, and College Park have committed to the VEO team hosting events in their cities. The VEO Manager has been in constant contact with external affairs to update content on the website, provide social media content, order collateral, respond to media inquiries and develop advertising material for events. FGTV also shot a video with the VEO team posted on the Fulton County Youtube Channel.

The VEO team has implemented a monthly training schedule for Deputy Registrar in person and virtual for all Fulton County Citizens that want to train to conduct voter registration drives. LaShandra has been working with the VEO Team Lead to update all training materials to reflect the most accurate information for the 2022 election cycle and create training in categories vs. a one-size-fits-all method. Training will be broken down by age and classification. The VEO team was trained on TVIC equipment and will be able to begin printing voter identification cards for those citizens that need them during outreach events. Also, the VEO manager has been holding training with the team to ensure they are up to date on poll worker recruitment information and are abreast of all current issues and topics.

The focus for March is to develop SOPs for the VEO team for events, presentations, and training. We will also focus on broadening our reach in North Fulton County. Also, LaShandra is working with Morehouse College to host a series of deputy

registrar training on the campus to increase civic engagement. The VEO team will also host a VEO Day at the State Capital on March 21, 2022.

As the Legislative Liaison for the Department, LaShandra will keep the leadership team aware of all legislation impacting elections in collaboration with external affairs.

The VEO team will continue to contact schools, communities, non-profit organizations, and government officials regarding scheduling future events. We are developing ongoing outreach opportunities with various groups to strengthen our impact in the community.

O.C.G.A. § 21-2-381

(G) Any elector meeting criteria of advance age or disability specified by rule or regulation of the State Election Board or any elector who is entitled to vote by absentee ballot under the federal Uniformed and Overseas Citizens Absentee Voting Act, 42 U.S.C. Section 1973ff, et seq., as amended, may request in writing on one application a ballot for a presidential preference **PRIMARY** held pursuant to Article 5 of this chapter and for a primary as well as for any runoffs resulting therefrom and for the election for which such primary shall nominate candidates as well as any runoffs resulting therefrom. If not so requested by such person, a separate and distinct application shall be required for each primary, run-off primary, election, and run-off election. Except as otherwise provided in this subparagraph, a separate and distinct application for an absentee ballot shall always be required for any special election or special primary.
